(Licensure Grades Birth – Grade 3*)
*Changing to Birth – Grade 2

Completion of an Associate in Arts (AA) or Science (AS) degree at Southwestern Illinois College (SWIC) fulfills SIUE's general education requirements for the Early Childhood Education Program with the exception of ED 255, PSYC 250, nine hours of upper level Academic Emphasis Area coursework, and an Interdisciplinary Studies course which must be taken during your junior or senior year at SIUE. The classes below meet the requirements for the AA at SWIC. ED 255 and PSYC 250 are required for admission to the Early Childhood Program at SIUE.

Below you will find the curriculum for Early Childhood Education majors. Although SIUE recognizes the Illinois Articulation Agreement, failure to follow the recommended curriculum may result in the inability to pass the required Illinois Content Area Test prior to student teaching. This test covers knowledge in the areas of child development, identifying and working with learning-challenged children, and encouraging age-appropriate progression through classroom activities. It is your responsibility to prepare for the examination. Also, these courses are designed to help students teach these subject areas after graduation. Please see an advisor in the School of Education Student Services office at SIUE to help you prepare for your transition to SIUE as soon as possible. TAP/ACT Testing Requirements:

The Test of Academic Proficiency (test code 400) must be passed to declare as an Elementary Major. Students must have a passing score of 240 on each subarea of the test as required for the admission process to the Partnership Program. Students have a maximum of 5 attempts to pass the Test of Academic Proficiency and will need to provide all scores to their School of Education Student Services Advisor. A mandatory 60 day waiting period is required before retaking the test. Testing website: http://www.il.nesinc.com/

Students now have the option to use their ACT score in lieu of taking the Test of Academic Proficiency (TAP). In order for students to use their ACT score, they must have taken the ACT Plus Writing Test within the last 10 years and received a score of 22 or higher. Please contact the School of Education Student Services office for more information on using your ACT score for admissions requirements.

Academic Emphasis Area – Students without the AA or AS will be required to complete 18 hours – nine hours at the lower level and nine hours at the upper level: Choose courses from at least 2 of the following areas. 9 of the 18 semester hours must be at the 300-400 level. Students with an earned SWIC AA/AS degree have 9 hours of lower level courses waived. (Bolded courses are recommended options). Courses at the 300/400 level should be taken at SIUE.

- 1) Mathematics (Mathematics, Computer Science, and/or Statistics) MATH 107
- 2) General Science (Physical Geography, Physics, Chemistry, and/or Biology) ANTH 160, ATY 101, BIOL 100, BIOL 105, CHEM 100, ES 102, ES 250, & PHYS 101)
- 3) <u>Social Science</u> (History, Political Science, Cultural Geography, and/or Economics) **ANTH 150**, **GEOG 151**, HIST 151, HIST 152, HIST 230, **HIST 288**, **HIST 292**, POLS 125, **POLS 150**, & POLS 262
- 4) <u>Language Arts</u> (ENG) **ENG 207**, LIT 117, LIT 120, LIT 201, LIT 202, **LIT 213**, **LIT 214**, & **LIT 215**
- 5) Foreign Language SPAN 101/ SPAN 102, FREN 101/102, GERM 101/GERM 102
- 6) Psychology/Sociology **PSYC 250**, PSYC 251, SOC 153, SOC 230, **SOC 255**
- 7) <u>Art/Music/Theater</u> ART 104, **ART 105**, **MUS 103**, **MUS 124**, **SPCH 220**, **THEA 120**
- 8) Other Professional Education courses to be selected in consultation with an School of Education Student Services advisor can be part of the 18 hours (i.e. CI courses taught in the summer or Sign Language course taught by Special Education.) Please consult an School of Education Student Services advisor.

<u>Applying to the Partnership Program</u>: Applications are available early spring semester (January) with a due date in late spring semester (April 1) for the fall semester admittance. Contact your School of Education Student Services advisor for specific application deadlines. Please be aware that meeting minimum requirements to declare a major in Early Childhood does not guarantee acceptance into the Partnership Program.

ECHOS

(Early Childhood On Site Program)

This program allows students to complete an Illinois teaching licensure Type 04 or an Early Childhood Education degree without licensure, while still pursuing their present job. Practicum hours are required; however placements and scheduling are flexible to best fit the needs of working students. New students will be admitted Fall semester. Classes are offered in the evenings and on-line. The program can be completed in three years plus student teaching hours if students take two courses per semester. Students who are working in an early childhood setting may be able to complete some or all of their student teaching in their current place of employment while being paid.
