Exports are a Significant Portion of Illinois' Economy^A

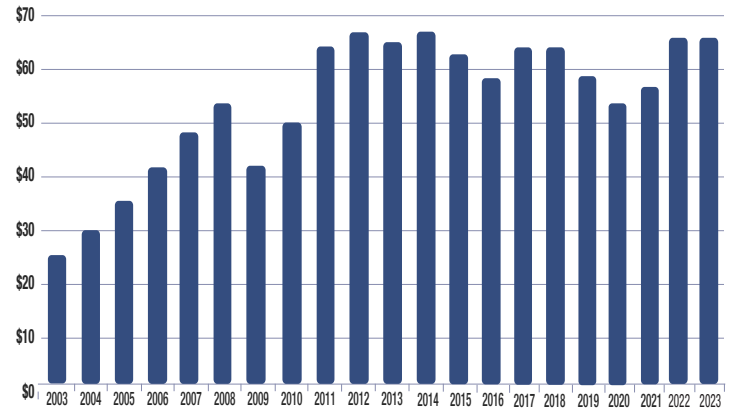
- Preliminary Illinois exports totaled over \$78.72 billion in 2023. The preliminary agricultural adjusted figure for 2023 is \$81.0 billion.^C
- Since 2019, Illinois exports have increased by \$18.96 billion or 31.7%
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts^C
- 11 out of top 20 export industries increased since 2022
- 18 out of top 20 export industries increased since 2019
- Top 7 Illinois export industries have seen gains since 2019
- 19 of the top 20 Illinois export partner countries have seen gains since 2019
- Export activities support over 800K jobs in Illinois^B

Illinois' Export Growth Comes from Around the Globe

- 15 of Illinois' partner countries' markets are worth over a billion dollars in export value
- United Kingdom was the largest single contributor to growth, with a \$745.8 million, or 38.4% increase over 2022
- Other notable growth markets include Netherlands \$362 million (17.5%) and Mexico \$1.40 billion (12.18%) increase over 2022
- 19 of the top 20 Illinois export partner countries have seen gains since 2019

Illinois Exports a Diverse Range of Products

- Computer And Electronics Products was the single largest top 10 contributor to growth by percentage, with a 20.2%, a \$1.63 billion dollar increase over 2022
- Primary Metal Manufacturing was the second largest contributor to growth by percentage with a 18.1%, a \$481 million increase over 2022
- Machinery, Except Electrical recorded gross export sales increases of about \$942.7 million over 2022
- Electrical Equipment, Appliances, And Component recorded gross export sales increases of about \$250 million over 2022
- 18 of the top 20 industrial export categories have seen gains since 2019
- 15 Illinois export industries are valued at over \$1 billion dollars in total exports

Foreign Direct Investment (FDI) in Illinois

- Over 2,678 firms that employ more than 550,763 people in Illinois^{D*}
- Illinois is ranked 2nd among all states and Chicago 1st among all metropolitan areas in locations for new and expanded corporate facilities (Site Selection Magazine, 2024)
- Chicago is the commercial capital of the U.S., with two of the top international exchanges (Chicago Board of Trade and Chicago Board Options Exchange)
- Chicago is the #1 container hub in the western hemisphere. Cargo moving between Asia, Europe, and the Americas often passes through Chicago, making it a crucial transfer hub
- O'Hare is among the world's busiest airports, served by all major international carriers and the only "dual hub" airport system in North America, handling over 2,239 passenger flights a day (plus over 83 cargo flights a day), flights to more than 1,077 routes, 46 countries servicing over 134 airlines
- Foreign trade zones, located at eight sites across the state, offer low-cost production and warehousing facilities for import- and export-bound products
