# Job Description/Responsibilities

Under the direction of the Assistant Director of Recreational Programs, the Club Sports Coordinator is responsible for the planning, development, implementation, and evaluation of a comprehensive club sports program. The selected candidate will oversee day to day operations, administration, planning, development, and supervision of 40+ club sports programs and over 700 student athletes. Duties for the Coordinator will include assistance with academic compliance, review of league eligibility requirements, risk management, oversee the health and well-being of student participants, schedule facility and rental space, handle sports official contracts, manage tournament organization, and arrange travel accommodations for Clubs. The Coordinator will also oversee and manage Club budgets and expenditures, while assisting with fundraising efforts, donations, and sponsorships.

Candidates must be able to plan, supervise and administer special event activities for the entire campus community. In addition, the Club Sport Coordinator will serve as an advisor mentor for participants of our programs, as well as student employee staff, and aid the Assistant Director for Recreational Programs in other aspects of the total operation as deemed necessary.

Further duties and responsibilities may be assigned in support of the department's mission and goals. Due to the professional responsibilities, some evening and weekend hours maybe required.

- 1. A Bachelor's degree in a field relevant to the position (e.g., Kinesiology, Physical Education, or closely related field).\*
- 2. Two (2) years (24 months) of experience in the promotion, design, development, and administration of recreational programs.\*
- 3. Current certification/licensure, from a nationally recognized professional organization, requiring continuing education and/or ongoing documentation of proficiency in specialty area required of position such as certified pool operator, first aid instructor, lifeguard certification, CPR, AED, personal training, the Group Fitness Instructor Certification from the American Council on Exercise (ACE) or the Personal Trainer Certification from the Aerobics and Fitness Association of America (AFAA) or similar license/certification etc.).

\*Please Note: An advanced degree (Master's or higher) in Kinesiology, Physical Education, Exercise Science, or closely related field may substitute in meeting the qualifications in number 1 and count for one year of experience in number 2 above.

#### **Preferred Qualifications**

- -Understanding of the Student Affairs Philosophy as it relates to the provision of recreational and leisure services to a university community.
- -Good oral and written communication skills are necessary to effectively interact with intramural sport participants and staff, as well as the recreation program staff.
- -Knowledge of the recreational sports profession and exhibit good management and supervisory skills along with an understanding of sports officiating.
- -Thorough understanding of recreational programming and scheduling of leagues and tournaments as well as experience in the supervision of Recreational Sports personnel and participants.
- -American Red Cross CPR, First Aid for the Professional Rescuer, and AED will be required upon hire.

### **Application Process**

This position is a current civil service vacancy at SIUE and will close to applicants at 11:59 pm CST, on the posting end date.

Applicants must submit a completed Civil Service Application, which must include complete employment history, through HireTouch. If you do not possess any employment history, you must indicate this within the employment history section of the application. Your application should reflect all relevant skills and experience related to the minimum qualifications listed for this position. While a resume may be submitted with the application, data for each employer must be listed on this application form. (The words "See Resume" may only be used as a substitute in the section entitled "Specific Duties Performed".) If the application is incomplete you will not be considered for the position as our office will be unable to evaluate your application to determine if you possess the required minimum qualifications.

If qualifying by education or to qualify for a required educational requirement, you must submit your transcripts, including those for SIUE, at the time of application.
