**Grade requirement for Licensure:**

All professional education and content-area coursework that forms part of an application for licensure, endorsement, or approval that is received on or after February 1, 2012, must have been passed with a grade no lower than "C" or equivalent in order to be counted towards fulfillment of the applicable requirements.

**Retention Policy:**

Students must maintain at least a 3.0 GPA in professional education and special education courses to remain in the program. If the student fails to earn a C or above in education coursework or maintain the required GPA, the student will be required to reapply to the program.

**Illinois Teaching Licensure:**

The Special Education program at SIUE leads to an Illinois PEL Type 10 (Pre-K through Grade 12), Learning Behavior Specialist I (LBS1).

**Optional Addition to Licensure:**

Early Childhood Special Education Approval when added to SPE 441 & 442  
This approval allows these individuals to teach early childhood special education non-categorical for children up to the age of 6.
