- V. Resolution Regarding School Reopening for AY2020-2021
 - The Board reviewed the Resolution Regarding School Reopening AY2020-21 that proposed to authorize the Chief Executive Officer/or Designee to prepare, amend, and implement plans for the return to in-person learning, remote learning, blended remote learning, and/or e-learning; and because the challenges presented by the ongoing COVID-19 pandemic are uncertain, unpredictable, and ever changing, the Board of Directors desires to provide the Chief Executive Officer/or Designee with reasonable direction regarding the re-opening of schools for the 2020-2021 school year, but also maximum flexibility in doing so. Shrylene Langston moved that the Board accept the Resolution as presented. Jessica Harris seconded the motion. Roll call vote was taken and motion passed unanimously.

Dr. Jeffries informed the Board that she is recommending completely online opening for first quarter August 17-October 16, 2020 in line with rising COVID cases in East St. Louis District. District 189 is also opening remotely. The Board discussed issues surrounding an online opening.

- VI. Agreements Gina Jeffries
 - a. Employee Assignment Agreement FY21 This agreement is an MOU with SIUE that Charter High School employees are SIUE employees on loan to Charter High School. This is a continuation of that agreement. This is a one-year agreement in line with the Charter renewal term.

 b. Lease Extension Agreement This document is an extension of our existing lease with SIUE E. St. Louis Campus space for July 1, 2020 to October 31, 2020. See Attachment #23for complete agreement.

New Lease Agreement – terms included some of the new square footage and a room for school nurse. Rent per square foot is important part of renegotiating Charter with District 189.
