Financial Statement for 1 year of study	Must be dated within the past 6 months
Photocopy of your U.S. Visa in your passport	Be sure the copy is legible

Photocopy of your passport expiration page	Your passport should not be expired
Photocopy of your spouse's current I-20	All pages are required
