

## Office of International Students & Scholars 24-Month STEM OPT APPLICATION INSTRUCTIONS

Enclosed is your new I-20 with the STEM OPT authorization. In order to apply for the STEM OPT Extension, you must file a Form I-765 along with a copy of the new I-20 and other required supporting documentation.

REQUIRED DOCUMENTATION

<b>F-1 Entry Visa OPT EAD card</b> —copy of the front and back of your current card (also called the Employment Authorization Document (EAD) card)

<ul> <li>Two NEW passport-style photos:         <ul> <li>Photos used for previous passport or visa applications cannot be used. To see an example, go to <a href="https://travel.state.gov/content/passports/en/passports/photos/photo-composition-template.html">https://travel.state.gov/content/passports/en/passports/photos/photo-composition-template.html</a> </li> </ul> </li> <li>Use a ballpoint pen (not a gel pen) to print your name and I-94 number on the back of each picture and place in a small envelope marked PICTURES.</li> </ul>
<ul> <li>\$410 Application Fee—Choose one of the following payment options:         <ul> <li>Credit card payment—Be sure you enter the correct card information and have sufficient funds available to charge \$410 or your application will be rejected.</li> </ul> </li> <li>Use Form G-1450 Authorization for Credit Card Transactions         <ul> <li><a href="https://www.uscis.gov/g-1450">https://www.uscis.gov/g-1450</a></li> </ul> </li> <li>Personal check—make it payable to: U.S. Dept. of Homeland Security</li> <li>Money order—can be purchased at the post office or a bank for a small fee</li> </ul>
<ul> <li>SIUE Diploma:</li> <li>If your diploma is not available, you can submit an official transcript from the Registrar's office showing degree completion. ## ASSEMBLING YOUR STEM OPT EXTENSION APPLICATION

Be sure to make a photocopy of your entire application for your records after you have assembled it in the following order:

1. \$410 application fee	
2. Photos (name & i-94# printed on back of each photo; place in envelope labeled PICTURES)	
3. Form G-1145: Request for e-Notification	
4. Form I-765: Application for Employment Authorization, all pages 1-7	
Photocopies:	
5. Signed OPT STEM I-20 by advisor & student, page 1 (NOT the original)	
6. OPT STEM I-20, page 2 (NOT the original)	
7. Passport	
8. F-1 Visa Stamp	
9. I-94 printout	
10. Current OPT EAD card, front & back	
11. SIUF Diploma or Official Transcript	

Once you have made a copy of your application, attach your application fee and PICTURE envelope to the front of the entire application packet.

## SHIPPING YOUR STEM OPT APPLICATION

It is your responsibility to make sure USCIS receives all required application materials in a timely manner. USCIS must receive your application within 15 days of the date your new STEM OPT I-20 was issued (the dates on the I-765, check and photos must be less than 30 days old), and before the end of your 60-day grace period. Send your completed OPT application packet with TRACKING to USCIS.
