### 24-Month STEM OPT APPLICATION INSTRUCTIONS

Enclosed is your new I-20 with the STEM OPT authorization. In order to apply for the STEM OPT Extension, you must file a Form I-765 along with a copy of the new I-20 and other required supporting documentation.

#### REQUIRED DOCUMENTATION

- ☐ **Form I-765: Application for Employment Authorization, all pages 1-7**

- ☐ **Form G-1145: Request for e-Notification**
  - Use the fillable form which is available online at: <https://www.uscis.gov/g-1450>This form provides an e-confirmation of the receipt of your application by USCIS.

#### PHOTOCOPIES OF IMMIGRATION DOCUMENTS

- ☐ **Passport ID page**—showing photo and expiration date (include the renewal page if applicable.)
- ☐ **I-94 printout**—pdf instructions for accessing your most recent one are available at <http://www.siu.edu/iss/arrival/getting-your-i-94-number.shtml>
- ☐ **F-1 Entry Visa**
- ☐ **OPT EAD card**—copy of the front and back of your current card (also called the Employment Authorization Document (EAD) card)

#### ADDITIONAL DOCUMENTATION

- ☐ **Two NEW passport-style photos:**
  - Photos used for previous passport or visa applications cannot be used. To see an example, go to <https://travel.state.gov/content/passports/en/passports/photos/photo-composition-template.html>
  - Use a ballpoint pen (not a gel pen) to print your name and I-94 number on the back of each picture and place in a small envelope marked PICTURES.
- ☐ **\$410 Application Fee**—Choose one of the following payment options:
  - Credit card payment— *Be sure you enter the correct card information and have sufficient funds available to charge \$410 or your application will be rejected.*  
Use Form G-1450 Authorization for Credit Card Transactions

  - Personal check—make it payable to: U.S. Dept. of Homeland Security
  - Money order—can be purchased at the post office or a bank for a small fee
- ☐ **SIUE Diploma:**
  - If your diploma is not available, you can submit an official transcript from the Registrar's office showing degree completion. To request a transcript from the Registrar, go to: <https://www.siu.edu/registrar/services/student-records/requesting-a-transcript.shtml>

## **ASSEMBLING YOUR STEM OPT EXTENSION APPLICATION**

Be sure to make a photocopy of your entire application for your records after you have assembled it in the following order:

- \_\_\_\_\_ 1. \$410 application fee
- \_\_\_\_\_ 2. Photos (name & i-94# printed on back of each photo; place in envelope labeled PICTURES)
- \_\_\_\_\_ 3. Form G-1145: Request for e-Notification
- \_\_\_\_\_ 4. Form I-765: Application for Employment Authorization, all pages 1-7

- \_\_\_\_\_ 5. Signed OPT STEM I-20 by advisor & student, page 1 (NOT the original)
- \_\_\_\_\_ 6. OPT STEM I-20, page 2 (NOT the original)
- \_\_\_\_\_ 7. Passport
- \_\_\_\_\_ 8. F-1 Visa Stamp
- \_\_\_\_\_ 9. I-94 printout
- \_\_\_\_\_ 10. Current OPT EAD card, front & back
- \_\_\_\_\_ 11. SIUE Diploma or Official Transcript

Once you have made a copy of your application, attach your application fee and PICTURE envelope to the front of the entire application packet.

## **SHIPPING YOUR STEM OPT APPLICATION**

It is your responsibility to make sure USCIS receives all required application materials in a timely manner. **USCIS must receive your application within 15 days of the date your new STEM OPT I-20 was issued (the dates on the I-765, check and photos must be less than 30 days old), and before the end of your 60-day grace period.** Send your completed OPT application packet **with TRACKING** to USCIS.
