SUAAction

Illinois' current population is 12.65 million.

The State could lose at least one congressional seat and one electoral vote in the Electoral College upon final confirmation of the 2020 Census.

Unfortunately, the US Census Bureau will not be able to provide the Illinois population data until September, since the pandemic slowed the gathering of this much needed information.

The Illinois Constitution requires a new redistricting map be approved by June 30, 2021. A formal decision about what to do has not been made. It is clear that a decision needs to be made soon.

All legislators – both House and Senate – will be up for re-election in 2022. This can cause problems with filing to run for an elected office, as those deadlines cannot be initiated earlier. Due to the decrease in population, Illinois will most likely lose another congressional seat. There are currently 18 congressional seats. Illinois peaked in 1949 – 1953

with 26 seats. The 26th congressional district of Illinois was created in 1949 but was eliminated due to the result of the 1950 Census.
