II. Relationship to Knowledge Base

This course integrates knowledge of the teaching field with knowledge of pedagogy. Students engag

e in inquiry about the teaching-learning process and develop practical strategies for planning lessons, managing classrooms, and evaluating learning. This course provides background and experiences consistent with Illinois Professional Teaching Standards. While all standards receive some coverage, CI 315A focuses on IPTS 4, 5, 6 and 8; Technology Standards 3 and 4; and Language Arts Standards 1 and 2.

III. Goal

By the end of this course, students should have a clearer picture about the operation of schools and various approaches to instruction in preparation for student teaching.

IV. Program Objectives Related To This Course

This course is designed to enable students to:

- Assess their current views on instructional development
- Become familiar with a variety of classroom situations
- Consider necessary balances between continuity and variety
- Develop specific plans for classroom instructional practices
- Elevate awareness of issues of diverse populations
- Foster an understanding for different learning styles

V. Course Topics

The major topics may not be in this order but to be considered are:

- The historical debate about best practices in schools
- Organizational patterns in schools and their relationships to instructional planning
- Popular trends that influence planning, implementation & grading
- International, national, & state issues related to instructional practice
- Classroom management and discipline
- Standards and their relationships to instruction

Methods and activities for instruction include:

- Meetings of content area groups
- Extensive discussion of issues related to planning, implementation, & grading
- Technology-based instruction
- Historical and conceptual analysis
- Organized visits to several schools and classrooms
- Discussions of issues that arise in the course of such visits
- Skits, role playing, and debates

The methods of evaluation and criteria for grade assignment are:

- Attendance, punctuality, and participation
- Successful completion of portfolio materials
- Successful completion of classroom observations
- Explanation of unit plans in seminar
- Small group participation
- Summary for final class period
